The **Nutan Mahavidyalaya, Sillu** (hereafter referred as **NMS**) and **Late. Nitin Arts and Science Mahavidyalaya, Pathri Dist. Parbhani (MS)** (hereafter referred as **LNASM**) wish to initiate the collaboration in different discipline through mutual memorandum of understanding (MOU) on **06/01/2020**.

NMS and **LNASM** recognize their strength in education and research in the discipline of Science, education and languages, and their mutual interest in engaging themselves in academic cooperation for the improvement of subject knowledge as well as expertise.

Therefore **NMS** and **LNASM** are agree to establish a programme for academic cooperation in the areas of mutual interest and in accordance with terms and conditions laid down in this memorandum of understanding.

[I] Objectives

The goal of this co-operation is to foster collaboration, provide opportunity for expertise and experience, and to facilitate advancement of knowledge on the basis of reciprocity, best efforts, mutual benefits and frequent interactions. **NMS** and **LNASM** agree to explore the possibility of engaging in any field related to Science, Technology and Languages such as English of mutual interest and particularly in below mentioned fields.

1. Provision of consultancy for the campus development of either institute.
2. Exchange of information on teaching, learning materials, research and other literature relevant to their educational and research programme.
3. Exchange of English language faculties for knowledge transformations.
4. Exchange of English language students for knowledge improvement.

5. Joint organization of students' seminars, workshops, short term educational program on topics of mutual interest while extending the invitation to each other's faculties to participate therein.
6. Joint proposal and engagement in research or training programs sponsored by funding agencies, while extending invitations to each other's faculty to participate therein.
7. Exchange on a reciprocal basis of students at undergraduate levels for limited period of time for purpose of education and or research.
8. **NMS** and **LNASM** will encourage collaboration in research areas of mutual interest.

[II] Faculty exchange

1. **NMS** will welcome **LNASM** and English language faculties to visit **NMS** to engage in delivering lectures, practical's, experiences and scientific research.
2. Reciprocally, **LNASM** will welcome English language faculties from **NMS** to visit **LNASM** in order to engage in delivering lectures, practical's, experiences and scientific research.
3. Proposals concerning the topics, persons and periods of visits will be sent within a reasonable time in advance of the proposed visit.

[III] Student exchange

1. **NMS** and **LNASM** are agreeing for an exchange of students nominated by the respective Departments in order to carry out studies as provided for in this agreement.
2. Both Departments also encourage exchange of students in the context of professional internship.

3. The participating students will continue as students for degrees of their parent Department, and will be enrolled as affiliate (or non-award, non-degree) students in the host Department.
4. The exchange will be for a mutually approved duration of time which may not exceed a total of 12 months (barring special cases, at the discretion of the signatories of the MOU).
5. Each Department will nominate students for the exchange, and forward relevant data concerning the students to the host Department. An official academic transcript relating to the students concerned shall accompany such nominations.
6. The host Department will decide on the acceptability of the students nominated, and identify an appropriate supervisor.
7. It is expected that the host Department will accept the nomination except in extraordinary circumstances; and in such cases the parent Department will submit another application for consideration.
8. For every exchange, student under Course program, the host Department will send transcripts of their grades in the courses to the parent Department at the end of the tenure/term.
9. Every exchange student under a joint-research program shall pursue a research program which is developed in consultation with the parent Department, and which is not in conflict with the regulations of the host Department. The appointed supervisor at the host Department will provide a report on the exchange student to the parent Department on completion of his/her tenure/term. However, the two supervisors' will jointly guide the students, until they complete their project work.

10. The project report will be written in the language of the parent Department. A copy of the same in the language of the host Department will be sent to the host Department for record.
 11. Each exchanged student will have the rights and responsibilities enjoyed by other students on the host campus.
 12. The host Department will provide an assistance to exchange students in finding appropriate accommodation.

[IV] Resources exchange

NMS and LNASM will examine the possibility of exchanging some technical experts in the field of language either to support the faculty of reciprocal Departments, which could include Laboratory and Departmental Library support staff etc. in the vicinity of practical and experimental understandings.

[V] Language Software

1. Efforts will be made to share the information about Language Software activities in order to establish contacts and collaboration between professionals working within the same field.
2. Language Software and the composition of teams will be approved by the participating Departments. Efforts will be made to evaluate the need of participating staff and the location of the research activity.
3. Every Team will have a team leader, who will be responsible for reporting on the Language Software.

[VI] Confidentiality

It is anticipated that it may be necessary for NMS and LNASM to disclose certain confidential and proprietary information in written, oral, visual and or physical/sample form, and the receiving party may otherwise come into a control or possession of certain information, including such information as collectively defined as confidential information. The Receiving Department shall maintain the disclosing Departments confidential information in confidence and shall exercise in relation thereto no lesser security measure and degree of care than which the receiving Department applies to its own confidential information which the receiving Department warrants providing adequate protection against unauthorized disclosure, copying or use.

For the purpose of this clause, the term Confidential Information shall mean and include any information disclosed by disclosing Department to the receiving Department, either directly or indirectly, either orally or in writing, by inspection of tangible objects (including, without limitation, documents, prototype, samples, media, documentation, disc and code).

Confidential information shall not include information or data which:

1. It is in or comes into the public domain or generally available to the public in any way without breach of this MOU by the receiving Department; or
2. The receiving Department can show that such information or data was in its or its representatives possession or within its knowledge or its representative's knowledge by being in its use or being recorded in its files or computers or other recording media prior to receipt from the disclosing Department and was not previously acquired by the receiving Department from the disclosing Department under an obligation of confidence;

3. The receiving Department obtains from a source other than the disclosing Department without breach by receiving Department or to the best knowledge of the receiving Department, such source or any obligation of confidentiality or non-use towards the disclosing Department.

[VII] Intellectual property right (IPR)

Information on research results and materials (reports, articles, books) will be exchanged freely keeping in mind the mutually agreed provision of Intellectual Property Rights. All intellectual property solely conceived and/or developed by NMS and **LNASM** jointly during the course of this Agreement shall be owned in joint. All intellectual property solely conceived and/or developed by **NMS** during the course of this Agreement shall be owned by **NMS**. Intellectual property jointly conceived and/or developed by **NMS** and **LNASM** will be jointly owned by **NMS** and **LNASM**. Each Department may use such property for research and scholarly purposes. **NMS** and **LNASM** agree to collaborate towards the protection, if appropriate, and application of such intellectual property for commercial or other purposes on mutually acceptable terms to be negotiated in good faith between the Departments.

[VIII] Funding for activities

1. The two Departments will seek funding for the link program from various sources.
2. The acquired funds will be subject to accounting procedures of the two Departments.
3. The collaborating Departments will offer logistic support for initiating the collaboration and for working out draft proposals for the activities.

4. The cost of visit of faculty or students to the reciprocal Department would be either born by individual or parent Department.

[IX] Mere understanding

This MOU only represents a basis of understanding between **NMS** and **LNASM** towards one or more formal agreement as may be executed by the Departments. It is clarified that this MOU does not constitute an agreement and therefore is not enforceable as an agreement.

[X] Co-coordinator

Both Departments will designate persons who will have responsibility to coordinate and implement this agreement in the benefit of the institute.

[XI] Co-ordination

The following arrangement is suggested for the coordination of collaboration;

1. Each Department (**NMS** and **LNASM**) shall appoint one member of its teaching to coordinate the programme on behalf of respective institute.
2. Coordination committee, consist of (a) HOD, **NMS** or his/her nominee, (b) HOD, **LNASM** or his/her nominee, (c) Programme coordinator from **NMS** and (d) Programme coordinator from **LNASM** will periodically review and identify ways to strengthen cooperation between the two Departments.

If any dispute persisted regarding any aspects of academic cooperation, HOD, NMS and HOD I.NASM will jointly resolve the dispute in a spirit of independence, mutual respect and shared responsibility.

[XIII] General provisions:

1. The two Departments will carry out teaching, learning activity as a follow up to this MOU. The activities must be carried in accordance with appropriate regulations existing in each Department.
2. The two Departments shall initiate and exchange faculty as well as students for enlarging the dimensions of education.
3. All publications resulting from the collaboration between the two Departments will be mentioned in the scientific reports of the institute. Likewise this MOU must also be mentioned in all formal representations, which results from the collaboration under the terms of this MOU.

[XIV] Term and termination

1. This MOU shall remain in force for an initial period of five (5) years from the date of signing unless its validity is renewed for a further period mutually agreed by both Departments.
