Nutan Mahavidyalaya will nominate a faculty coordinator to facilitate communication and coordination with Bihani Agro Industry.


Bihani Agro Industry will designate a liaison officer to liaise with Nutan Mahavidyalaya and ensure effective implementation of collaborative activities.
